BY REGISTERED LETTER

Dear Aman Rai:

In response to a letter written by you on February 17, 2023 and received on March 6, 2023, I have enclosed the following documents:

- A copy of my sovereignty, which contains my vessel number
- **A copy of the RBC letter of July 18, 2022 that declares the Royal Credit Line paid in full in July, 2022**
- A copy of the email of March 1, 2022 to your thug, Corey Roberts after his attempt to break down the door to my house on three separate occasions, from February 25 through 28, 2022
- A CEASE and DESIST Order, dated March 24, 2023

This CLOWN show had better end right now, or I will seek remedy by filing harassment and trespass actions against you personally, and WBA Law LLP. That's only a first step.

I AM a sovereign man. Neither you, nor the fraudulent, corporate Maritime/Admiralty court system you hide behind, have any jurisdiction in the Kingdom of Canada. You are guilty of FRAUD on multiple levels. Let's just review your situation, shall we?

You and I know that you're part of a criminal conspiracy to defraud the public through baseless, fraudulent charges brought through the Maritime Legal System. Your objective is to gain access to my CESTUI QUE VIE Trust with the ultimate goal of illegally stealing the title to my land.

The problem you have is on several levels:

- **I AM a sovereign man and I do not contract with you.** As to your threats of court action, you're fully aware that the Maritime/Admiralty courts can only contract with a CORPORATION, vis à vis an entity in CAPITAL LETTERS — a LEGAL FICTION — specifically, my STRAWMAN account (TRUST).
- You are masquerading as a lawyer, but are actually a B.A.R attorney, promoting a legal fiction, the Maritime/Admiralty court system itself, that pretends to have some relationship to government. Of course, it does not. It has no jurisdiction on land and, in fact, commits FRAUD daily by duping men and women into contracting with these criminal courts, in order for you to conspire to defraud them through unlawful access to their CESTUI QUE VIE TRUST accounts. I have a sense the deception doesn't end there!
- **There is no debt in question; it has been repaid in full.** Therefore, you are committing FRAUD, and due to the fact that we're currently operating under martial law, this amounts to domestic terrorism, treason against We the People, punishable by death.
- You also know that the banking system is completely corrupt, as are you and your firm, and that the original loan in question was satisfied through the signed promissory note signed over thirty years ago, that was an illegal contract, but **was used to illegally access to my CESTUI QUE VIE TRUST**, to fulfil the obligation. The bank then fraudulently "loaned" me back my own money, charging compound interest.
- You are a foreign agent, a member of the B.A.R., having taken an oath to the CROWN, which, due to recent events, has no jurisdiction in the Kingdom of CANADA, and is, in fact, defunct. **The Act of England has been reversed, which renders all contracts after that date NULL and VOID.**
- **The government of Alberta is not currently a government at all, but a FOREIGN CORPORATION**, registered in Washington DC. It has no jurisdiction in the Kingdom of Canada and it's "politicians" are subject to a charge of treason.
- **The Kingdom of Canada has no federal government.** CANADA INC. went bankrupt years ago; Parliament has not met since that time. Parliament buildings are boarded up and members arrested; Trudeau was arrested years ago. This means the Maritime Legal System has no authority or jurisdiction (well, it never did on land) anywhere in the country.

Now, in a scenario with where you were to attempt to sue me, I would take great joy in making a Special Limited Appearance on behalf of "the defendant," my birth certificate. I'm the beneficiary of my CESTUI QUE VIE TRUST, of course, and will declare the judge the TRUSTEE, whence I will have the entire matter discharged with prejudice and declare damages in this case of \$100,000.00.

I would like to do this, but foreign agents across the world are currently being arrested and deported. It is happening now. You will experience a tribunal (I know you know what they are) and if you are guilty of the above, you will face retribution.

You are in a very serious situation. I would very carefully consider your options. I'm more than fed up with your harassment and fraud and will take action, but I truly believe the US Military Alliance will finish gathering up foreign agents before I get the chance.

As a professional television producer for some 45 years, I can tell you with authority, that the truth is about to hit the internet in a big way. It's already out there, but the momentum is building and will become a tsunami shortly.
