**BY REGISTERED LETTER**

**NOTICE TO AGENT IS NOTICE TO PRINCIPAL  
NOTICE TO PRINCIPAL IS NOTICE TO AGENT**

**DEMAND TO CEASE AND DESIST**

I AM Peter Temple, a sovereign man in the Kingdom of Canada, registration #RN499828825CA. I bring the following to your immediate attention and order you to cease and desist all fraudulent activities relating to any attempts to contact me, trespass on my property, or otherwise harass me, using any medium of communication.

**I claim SUI JURIS**

**I do not understand you. I do not have an international treaty with you. I do not comply and do not contract with you.**

You are a B.A.R. attorney, a foreign agent in the Kingdom of Canada and have no authority or jurisdiction within Canada whatsoever. You are misrepresenting yourself as a lawyer, when in fact, you are a B.A.R. attorney, having pledged allegiance to the CROWN.

The CROWN no longer has any relationship with the Kingdom of Canada, which you must be aware of. The principals/owners of the CROWN are bankrupt: This includes the Pope (Vatican), Queen Elizabeth II (executed December, 2019), the City of London, and the Rothschild family. **The Kingdom of Canada is currently a protectorate of the United States of America.** Hence, the B.A.R. and the Maritime Legal System (foreign CORPORATION) have no authority or jurisdiction within the Kingdom on Canada.

**The foreign CORPORATION, CANADA INC (CIK 0000230098) went bankrupt in 2018 and ceased to have jurisdiction within the Kingdom of Canada.** The "Demise of the CROWN," which has now passed to Queen Diana, as the Royal Family have all been executed, requires the allegiance of the Privy Council, which has been disbanded.

**The PROVINCE OF ALBERTA, as a foreign CORPORATION, has no jurisdiction within the Kingdom of Canada.** You can find the registration information on the EDGAR database hosted in Washington, DC, also under a foreign CORPORATION.

The Act of England (1871) has been reversed. All contracts signed since 1871 are NULL AND VOID.

As such, you are guilty of **FRAUD** based upon the definition in Black's Law Dictionary:

**A. fraud, n.**

1. A knowing misrepresentation of the truth or concealment of a material fact to induce another to act to his or her detriment . • Fraud is usu. a tort, but in some cases (esp. when the conduct is willful) it may be a crime.
2. A misrepresentation made recklessly without belief in its truth to induce another person to act.
3. A tort arising from a knowing misrepresentation, concealment of material fact, or reckless misrepresentation made to induce another to act to his or her detriment.
4. Unconscionable dealing; esp., in contract law, the unconscientious use of the power arising out of the parties' relative positions and resulting in an unconscionable bargain.

**B. misrepresentation, n.**

1. The act of making a false or misleading statement about something, usu. with the intent to deceive.
2. The statement so made; an assertion that does not accord with the facts. - Also termed false representation; (redundantly) false misrepresentation.

You are also perpetrating **FRAUD** with a recent letter to me dated February 17, 2023 threatening legal action to attempt to sell my home based upon an fabricated assertion that an RBC line of credit is owing. **The line-of-credit, in fact, was paid in full in July, 2022, as per the enclosed letter from RBC, dated July 18, 2022.**

**You are also acting under Martial Law in Canada and may face extreme punishment for infractions against the civilian populace.** Acts of plunder, mortal violence, and mischaracterization of civilians as combatants are **all** death penalty offenses. Continued harassment of me will result in a charge of harassment in the Alberta court system that will be pursued with vigor.

Note also that there is a NO TRESPASSING sign is posted on the 21 Avenue SW property. Any instance of trespass with result in a charge of trespass, which I'm sure you're aware, carries up to a \$200,000.00 fine.

## **CEASE and DESIST IMMEDIATELY:**

Cease and Desist immediately:

- aiding and abetting the theft of a property based upon FALSE, BASELESS, and FRAUDULENT accusations.
- sending correspondence that misrepresents my God-given name
- any contact with Peter Temple through unsigned documents or attempts to confuse, whether it be through mail, in person, telephone, email, or other electronic means. At the very least, you will be charged immediately with harassment and may warrant military involvement.

## **Seeking Remedy**

We will be filing a NOTICE OF FRAUD with the PROVINCE OF ALBERTA, the Attorney General of the Province, along with the Premier and various levels of law enforcement.

**Due to martial law having been exacted, this case is being brought to the attention of the US Military and Allied Forces. Mass arrests are currently in progress across Canada and the United States to end the corruption evident through the courts, medical, financial, and political systems.**

**All paedophiles will face tribunals and if convicted of harming children, will be executed, no exceptions.**

If you do not immediately comply with this CEASE and DESIST order, I will seek remedy through the Canadian Common Law Courts.

**This will serve as your lawful notice to cease and desist all further actions described above, effective immediately.**
